by Frederick Warne & Company Limited to my said Husband William Heelis for and during the term of his natural life with remainder to my friend the said Frederick Warne Stephens absolutely -(f) - My freehold meadow at Satter Howe on the Ferry Hill to the National Trust absolutely to preserve the same in memory of the Men of Sawrey who fell in the Great War 1914-1919 -(g) \_ My Cottage and Barn adjoining and garden with yard adjoining situate at Crosby near Maryport in the County of Cumberland to Jenny Mackereth Widow of William Mackereth -(h) My property at Outgate near Hawkshead called Belmount Hall unto my Husband William Heelis for his life with remainder to the National Trust AND I DESIRE that the walled garden and the wood may be preserved in accordance with the wish of the late owner Miss Rebecca Owen as a Bird Sanctuary (1)\_ Such of my furnishings and objects of interest as may be in Troutbeck Park Farm House and in Hilltop Farm House unto my said Husband William Heelis for his life and after his death to devolve with such respective farms it being my wish that the rooms and the furnishings used by me at Hilltop Farm House may be kept in their present condition and not let to a tenant and it is my wish that any other objects of interest belonging to me in any other of my cottages and farmhouses may be preserved therein \_\_ I GIVE DEVISE AND BEQUEATH all the rest residue and remainder of my real estate to my Husband William Heelis for his life for the use and enjoyment of the whole or such portions thereof as he shall select and subject thereto UPON TRUST for the National Trust to be held by the Mational Trust as an inalienable property it being my intention and my wish that my said Husband shall decide what portion or portions of my said real estate shall immediately on my death be handed over to and held in trust by the National Trust Freed from the intervention of his life interest therein And it is my wish that the Mational Trust shall so far as possible let and manage the same on the same lines as previously let and managed during the lifetime of myself and my said Husband -- I DECLARE that my house property shall continue to be let at that my farms shall be let at moderate rents to good tenunts but that any offers of tenancy from any of my servants shall receive careful considera-I DECLaRS that the Landlords sheep stocks on my Fell Farms shall
